
Sir,

You are aware of the fact that, the Govt. of Odisha in Revenue and Disaster Management Department vide Notification No. 1706/R&DM dated 13.03.2020 has declared COVID-19 as a "Disaster" for the state of Odisha and Collector, Kalahandi is declared as the "Empowered Officer" u/s 2(1) of Epidemic Disease Act 1897.
