- vii) No extra payment will be made once the bidder is being given the work order based on the quoted price.

- viii) The firm required to deposit the security amount of **Rs 20,000/-** in the form of demand draft drawn in favour of "**Principal, Government College of Engineering Kalahandi**) Payable at Bhawanipatna along with tender documents.
- ix) The authority holds all the rights to offer the assignment to any of the Bidder in case of equal quotes.
