Sub: Modalities for implementation of Career Advancement Scheme (CAS) in Govt. Engineering Colleges.

Ref: This Department letter No. 1388, dtd 22.02.2023

Sir,

With reference to the subject cited above, I am to say that Government in Skill Development and Technical Education Department vide letter referred above, had allowed for the implementation of Career Advancement Scheme as per AICTE Regulation 2019, except for the provision of CAS promotion from Professor to Senior Professor for teachers of Government Technical Universities/ Engineering Colleges/ Institutions functioning under the administrative control of this Department.

The committee constituted vide this Department Letter No. 8571, dated 15.11.2023, had deliberated on formulations of the draft modalities for implementation of the Career Advancement Scheme (CAS) and suggested measures to bring about uniformity in the process adhering to the AICTE Regulations.

The Government, after careful consideration, have been pleased to adopt the modalities recommended by the Committee for standardising the process of implementation of the Career Advancement Scheme (CAS) in Government Engineering Colleges as per AICTE Regulations, 2019 including the amendments made or to be made in future. The detailed modalities as enclosed are to be strictly adhered to.

## **Modalities for implementation of Career Advancement Scheme (CAS).**

### **I. Screening-cum-Evaluation Committee (SEC):**

- A Screening-cum-Evaluation Committee shall be constituted at the institutional level to scrutinise applications and verify the minimum eligibility criteria as laid down in the AICTE Regulations 2019, including any subsequent amendments.
- The proposed composition of the SEC is provided in Annexure-A
- A standardised application format has been developed and is appended as Annexure-B.

### **II. Forwarding of Applications:**

- The SEC shall forward the names of eligible candidates along with their applications to the Selection Committee.
- A standardised format for recording the minutes of the SEC is enclosed as Annexure-C, and an abstract of recommendations, indicating either approval for promotion or rejection, is enclosed as Annexure-D.

### **III. Selection Committee:**

- A Selection Committee shall be constituted in strict adherence to the AICTE Regulations 2019, as amended from time to time.
- This Committee shall evaluate the shortlisted candidates through interviews, based on the criteria laid down under the AICTE Career Advancement Scheme.

### **IV. Interview and Qualifying Marks:**

- Candidates will be assessed through an interview at all stages of promotion.
- A minimum of 50 marks out of 100 in the interview shall be the qualifying benchmark for promotion.
- This threshold for qualifying shall be in accordance with the criteria prescribed by the OPSC for direct recruitment of faculty.

V. Standardisation of Formats and Criteria:

- The methodology for calculating 360-degree feedback has been aligned with AICTE norms.
- The minimum eligibility criteria for various promotional levels, as specified in the AICTE Appendix, have also been adopted.
- The format for recording the Selection Committee's minutes is enclosed as Annexure-E.

VI. Government Approval:

- It is reiterated that all promotions under the Career Advancement Scheme shall require prior approval of the Government as issued earlier.
