1. Sealed tenders are invited for supply and installation of Online UPS in the GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA. The tender document consists of the following two parts.
Part-1: "TERMS & CONDITIONS" & "TECHNICAL BID" of the tender.
Part-2: "FINANCIAL BID" of the tender.
2. The bidder must attach the at least 02 Purchase Order copy for Supply & Installation of above equipments during the last **One** financial years in State Government or Govt. of India Department(s) /Reputed Organisation(s) (in Nos. And Value). Please attach a list of clients.
3. The bids submitted by the vendors should be valid for a minimum period of 90 days from the date of the opening of tender and the prices should be valid till execution of purchase agreement.
4. The sealed envelope containing "The Bid" on prescribed tender document of the GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA should reach the "To the Principal, GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA-766002, At: Bandopala, Po: Risigaon" on or before **29.11.2017** up to 5:30 P.M through post only. otherwise the tender will not be accepted.
5. The Technical bid will be opened on **2.12.2017** at 03:30P.M. and the Financial bid will be opened on **03/12/17 at 3.00 P.M.**
6. The supply and installation of the above equipments shall be made by the vendor within 4 -6 weeks from the date of issue of the purchase order.
7. All the items to be supplied should be new, of good quality and standard and as per the technical specifications mentioned in technical bid document.
8. Discount: Any conditional discount will lead to the rejection of your tender.
9. The vendor will provide operational manuals, OEM documents for peripherals, set of diagnostics to test all the sub-systems etc. along with the systems.
10. The installation of above equipments will be at the GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA. The vender has to give undertaking that he/she will reinstall the equipment supplied by him/her at our campus at Bhawanipatna free of cost. The prices quoted in the technical/financial bid should be inclusive of power cables, interface cables,

packing, forwarding, freight upto GCEK, BHAWANIPATNA, transit insurance and installation charges at sites. Excise duty and trade tax if applicable should be quoted separately at the appropriate columns provided for them in the technical/financial bid (GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA is exempted from Excise Duty). All the expenses, like Import duty, Entry tax, and insurance will be added in your cost to calculate landed cost. (GCEK is exempted from Custom Duty. The present rate is approx. 5.13%).

11. In case, excise duty and/or trade tax/sales tax are reduced or increased subsequently by the Government at the time of placement of the purchase order or delivery, then the same will be adjusted by either party on production of requisite proof.
12. Payment for the items to be supplied by the vendor against the purchase order shall be made by GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA as follows:
 - Payment will be made after successful installation.The tenderers who are not agreeing to above payment terms, are requested not to submit their tender.
13. The equipments will carry three years on site comprehensive warranty. Warranty period will start from the date of successful installation of all the items at site.
14. Parties should specify the make and model of each Item along with all other details.
15. The tender must be submitted on the prescribed tender document issued by the GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA. Any other technical details required to supplement the information quoted in the prescribed tender document may please be attached separately. The information asked in the tender document should be given at the place provided for it in the tender document. The tenders in which information is not given at the place provided for it or not in the similar format given in the tender document may be rejected.
16. Printed conditions of the vendor submitted with the tender will not be binding on GOVERNMENT COLLEGE OF ENGINEERING KALAHANDI, BHAWANIPATNA.
17. The documents containing bids shall be free from cutting and erasures. However, alterations, if any, in the tender should be attested properly by the bidder, failing which the tender is liable to be rejected.
