**The approximate cost for the work is Rs. 3, 50,000/- (Rupees Three Lakhs Fifty Thousand only) including all taxes.** Quotations call documents must reach the office of the undersigned on or before 19/02/2026 **by 12 Noon** through **Registered / Speed post / Courier services/ By hand etc.** along with Demand drafts of **Rs. 17,500/-(Rupees Seventeen Thousand Five Hundred Only)** towards the Earnest Money Deposit (EMD) in favour of **Principal, Government College of Engineering, Kalahandi, Bhawanipatna** payable at Bhawanipatna. - The institute reserves the right to reject any or all or part of quotation without assigning any reason thereof.
- The institute will not under obligation, give any clarification to the Event Management Firm whose quotations are rejected/not selected.
- Rates quoted should be without any condition from the quotation. Conditional offer will be rejected.
- A copy of the work order has to be produced as a proof.
- The Bidder will provide the list of Artists on 26/02/2026. The programme will commence from 6 PM and will continue up to 12 PM. The stage will be handed over to the successful bidder for organizing the function on 26/06/2026 exactly at 6 PM.
- The artist's requirements for band must be provided by the firm. Light and sound will be provided by the College.
- The Bidder must guarantee the availability of the artist/star at the time of tender finalization.

- h) The Firm will be responsible for flights, transport and hotel accommodation of the Artists.
- i) The artists must reach Bhawanipatna on 26/02/2026 before 3 PM. It is sole responsibility of the firm to bring the Artists to College campus on time.
- j) The artists must carry themselves professionally, ensuring their behavior does not tarnish the event.
- k) The Artists generally cannot be substituted without the authority's prior written consent.
- l) The firm must provide a safe environment, security for the artist and their possessions.
- m) Failure to provide the contracted artist can lead to severe penalties or forfeiture of EMD or Performance security.
- n) No extra payment will be made once the bidder is being given the work order based on the quoted price.
- o) The firm required to deposit the EMD of Rs. 17,500/- in the form of demand draft drawn in favor of **"Principal, Government College of Engineering, Kalahandi"** Payable at Bhawanipatna along with quotation. This amount will be treated as performance security for the successful bidder. The EMD amount of the unsuccessful bidders will be refunded immediately after finalizing the quotation.
- p) The authority holds all the rights to offer the assignment to the Bidder having maximum average annual turnover for the last three years in case of equal financial quoted price in the financial bid (tie).
- q) GCEK, Bhawanipatna reserves the right to accept or reject any proposal and to annul the quotation process and reject all proposals, at any time prior to award of work order, without thereby incurring any liability to the affected bidders or any obligation to inform the affected bidders of the ground for rejection of any proposal.
- r) The bidders must submit their bids as required in two parts in separate sealed covers prominently super scribed as Part-I "Technical Bid "and Part-II "Financial Bid" and also indicating on each of the covers the "Quotation call Notice Number & Date" and due date and time of submission as mentioned in Quotation Call Notice.
- s) The schedule of the event is tentative and the authority reserves the right to change the date, which will be intimated to the successful bidder before one week.
