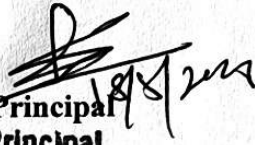

Eligibility Criteria

1. Companies/Bidders should be in existence for over two years in the business of providing AMC Services for RO Water Filters.
2. The firm/company should have a previous contract for AMC of RO Water Filters for at least one year with a Government Department/Public Sector Undertaking in the State of Odisha. The company should furnish its contract documents with a Govt. office for the last one year.
3. The commercial bid would be opened only after the technical bid is found satisfactory. Tender received after the prescribed cut-off date and time will be rejected forthwith.
4. The Vendor should submit an undertaking with the Technical Bid to the effect that he or his firm has not been blacklisted by any of the Departments/Organizations of the Government of India/Government of Odisha and no criminal case is pending against the said firm on the date of submission of this bid (Prescribed Performa as per Annexure E).
5. The vendor must furnish details of GST No. and PAN No. in Annexure-A and also submit the photocopy copy of these documents.
6. The rates quoted should be firm and in Indian Rupees. In case of any difference/discrepancy between the rates quoted in figures and words, the latter shall prevail.
7. The Tender Document with each page duly signed by the authorized signatory (who has signed the Bid), should be submitted with the Technical Bid in token of bidder's confirmation to accept the terms and conditions and other provisions contained in it.
8. The bidder shall quote the Technical and Commercial bids only as per the format enclosed at "Annexure-C" and "Annexure-D".
9. Conditional bids shall not be considered and will be rejected outrightly at the first instance.

SCOPE OF WORK AND TERMS AND CONDITIONS

1. Scope of work: Location of RO Water Plants installed in the premises of the College is as under:

Hostel	Capacity
VHR Hostel	250Litr/hour
MTHR Hostel(Ladies Hostel)	250Litr/hour
APJHR Hostel	250Litr/hour

2. The AMC is for **quarterly** preventive checks as well as for breakdown maintenance and includes repair of the following parts free of charge during the AMC period:

- All kinds of filters
- Pre-filter candle
- Carbon block
- RO Membrane
- Flow Restrictor Tube
- Post Carbon Filter
- Pump
- Adapter
- All Valves
- PCB (circuit)
- TDS Controller
- SV (Stopper)
- Motors
- Worn out parts etc.

- ROs will be checked on a quarterly basis to ensure the TDS level is within permissible limits. Valve, pressure meter, strainer will be replaced whenever required at free of cost.
- Filter/candle and sediment filter, electrical fittings (LPS, SV, Controller, sensor, dispensing switch, pump, SMPS and other electrical parts) with motors (if required) must be replaced whenever required at free of cost.**
- Membranes, PP spun must be replaced once in a year at free of cost.**
- It may be ensured that rates for parts of authorized brand or of standard quality only will be considered for replacement/repair under AMC. In case it is found at a later stage that substandard/inferior quality items supplied, necessary action will be taken against firm, including forfeiture of Performance Security and debarring them for quoting future tender.
- If the contractor fails to undertake the job satisfactorily at any period of time or withdraws his services, the College has every right to cancel the contract and forfeit the performance security deposit without assigning any reason whatsoever.
- The terms & conditions for AMC for the period of one year w.e.f. award of contract are as follows:
 - The firm will start working immediately after award of the contract.

- b) The firm will maintain the ROs as it is and where it is basis and will not charge extra money for any repairs.
 - c) The firm will attend to all complaints on receipt of information about breakdown/repair from the Superintendent of Hostels directly. The services would be provided on regular basis during day time and in case of emergency beyond working hours including holidays.
 - d) Proper record of servicing & repair etc. of the breakdown/maintenance would be maintained by the firm.
 - e) The bill will be paid after first visit of the firm.
 - f) No increase in amount shall be considered during the full period of AMC i.e. for one year. Charges like transportation fare etc. for providing the services for attending the complaints covered under this AMC will not be admissible.
 - g) Violation of any clause mentioned above will entail cancellation of the contract.
 - h) The College has the rights to terminate this AMC at any time without assigning any reason whatsoever, if the services are found to be unsatisfactory.
9. The rates quoted will remain valid for one year from the date of acceptance of this Commission's award of contract. However, the contract can be extended for a further period of one year at the discretion of the Authority on the same rates and the same terms and conditions.
10. The bidder who has quoted lowest rates will be considered.
11. The firm must have experience of at least 02 years in the maintenance of RO Plants/Water purifiers. The prospective bidder must also furnish a copy of PAN, GSTIN. In the absence of these documents, the quotation will not be entertained.
12. All quotations should be submitted before the time & date fixed for the receipt of quotations.
13. EMD of unsuccessful Tenderers will be returned/refunded once the work is awarded to the successful bidder. Offer without Earnest Money will be ignored. The earnest money/bid bond deposited by the bidder shall be forfeited by the College due to following reasons:
- (i) If tender is withdrawn during the validity period i.e. completion of process of awarding the contract.
 - (ii) If tender is varied or modified in any manner during the validity period or any extension thereof.
 - (iii) If a Tenderer, whose tender has been accepted, fails to furnish security deposit/performance bank guarantee within 10 (Ten) days of award of the contract. The bid will be cancelled and Earnest Money forfeited. The earnest money of unsuccessful bidders will be returned after completion of the process.
14. The EMD of successful Tenderer will be held as Performance Security by the College. This will be refunded on successful completion of the AMC.
15. An agreement will be signed by the firm after award of the AMC.
