- Item: Statue of Dancing Lord Nataraj
- Type: Free Standing Statue

- Material: High Grade Pure Brass
- Brass Composition: Minimum 60% Copper (Cu) and balance Zinc (Zn) or equivalent high-quality casting brass
- Manufacturing Process: Traditional Casting / Lost Wax Casting / Sand Casting (acceptable)

3. Dimensions

- Overall Height: 5 Feet (\pm 2 inches tolerance)

- Base Width: Proportionate to height for structural stability
- Depth: As per standard Nataraj statue proportion
- Base: Heavy Brass Base / Integrated Base, provision for installation in concrete base.

4. Weight

- Approximate Weight: 70 – 150 Kg (depending on casting thickness and design)

5. Finish & Surface Quality

- Finish Type: Golden / Traditional Temple Finish
- Surface: Smooth, polished, free from cracks, porosity and casting defects
- Corrosion Resistance: Lacquer / Protective Coating preferred.

- Traditional Nataraj Dance Posture (Tandava Form)
- Circular Prabhamandala (Flame Ring) around deity
- Detailed facial expression and ornamentation
